PSYCHIATRIC ASSAULT - AN ANATOMY OF TODAY'S TERRORISM

"Chaos and Terror Manufactured by Psychiatry - Report and recommendations on the role of psychiatry in international terrorism"

In the wake of the horrific and continued terrorist attacks around the world, there are many questions that remain unanswered. However, there is one unnerving question that is on everyone's mind.

"What sort of human being can be so cold-heartedly cruel and violently destructive of others and self, methodically planning and executing mass murder and suicide, with no apparent sense of the sheer inhumanity of their plan?"

While the words may vary, the essential question remains the same. Put more simply, "What sort of person is capable of such evil?"

This unthinkably hellish act has assaulted far more than innocent lives and our physical environment; it has assaulted our very senses. There is however, a way to face up to even the utterly unconfrontable: compare it to events with which we are already familiar — in effect, take a gradient approach to it. For the truth is, we have been here before, only to a more isolated or lesser degree.

Consider the insanity of Hitler's "final solution" and Nazi design, which terrorized the world 60 years ago, or Karadzic's or Milosevic's equally insane "ethnic cleansing" and terrorist purges in Bosnia and Kosovo in the 90's. While we may be emotionally insulated from these horrors by time or geography, the similarities are apparent.

But consider also that on April 20, 1999, in Colorado, USA, Columbine High School students Eric Harris and Dylan Klebold went on a shooting spree, killing 12 students and one teacher, wounding 23 others, and finally shooting themselves.

While on a comparatively minor scale, how is this similar to the terrorist attacks on New York and Washington, DC? What about inexplicable and unexpected violence, terror, innocent victims, death, destruction and the suicide of the protagonists, to name a few? And again, we asked the demoralizing question, "What sort of person is capable of such evil?"

Today, "experts" tell us that such terror merchants are not insane, mad or irrational. Is a terrorist therefore born with an innate impulse to butcher thousands of innocent people and terrorize millions more, while harboring a suicidal impulse? Is a terrorist someone of specific nationality, race or religion?

Expert opinion to the contrary, we contend that the scourge of terrorism *is* insanity and irrationality and that such insanity contains a continuous determination to harm or destroy. We also contend that

the terrorist is rarely born full-armed with murderous intent, nor is he peculiar to any one country, race or religion.

Ultimately, terrorism is no more than the product of *individual* madmen, and with those madmen, come equally mad agendas. But most importantly, today their evil is being amplified beyond belief by mental control techniques that were also born in hell. Today, such men are being influenced by psychiatric or psychological techniques aimed squarely at mind- or behavioral-control.

Injured during World War I, Hitler was hypnotized by a psychiatrist who implanted in him the belief that his beloved Germany needed him to recover in order to serve the cause of a national resurrection. German psychiatrists now admit that Hitler was influenced by their ideology of "racial inferiority" and "life devoid of value." Radovan Karadzic is the Sarajevo psychiatrist who lit the fires of racism in the Balkans. Karadzic's patient, Slobovan Milosovic, continued ethnic cleansing.

Harris underwent psychological anger management programs and was prescribed an antidepressant, side effects of which include mania, aggression and hostility.

The chief advisor to Osama Bin Laden, the alleged terrorist behind the recent attack on America, is a psychiatrist trained in psychological techniques, and capable of using drugs and other mental techniques to create suicide-bombers convinced of the glory of sacrifice and dying.

While we have known about psychiatric and psychological techniques for mind- and behavioral-control for some considerable time, never have we had such cause to question their hidden assault on our well-being, and the well-being of the world around us.

Terrorists are not sane, rational men; today, they are manufactured murderers.

While our mission remains strong, the senseless attack that took place here last Friday and the horrific events on Sunday at Pulse Club have had a life-changing impact on us all.



Mayor Dyer,

This is former Redondo Beach, CA Mayor and former USCM Advisory Board member Mike Gin.

I wanted to express my deepest condolences to you and your community on the horrific crime that was inflicted on your city last weekend. As a gay man, this past week for me has been full of emotion as I process the Pulse nightclub attack. I remember my 20's when a gay nightclub such as Pulse was a safe place for me to socialize as I was still dealing with the challenges and emotions of coming out as a gay man. Tears welled in my eyes as I thought about the terror that patrons must have felt in the Club early that morning.

Earlier this week, I made a call to Accredo Specialty Pharmacy and noticed that the number I had dialed had a 407 area code. I asked the representative on the line where they were based. The Accredo rep said that she lived in Orlando. She also mentioned that one of her colleagues at Accredo was still in the hospital after suffering injuries from the attack. My heart was broken as we both spoke about the attack.

I want to thank you and your community for the strength, compassion, and resilience that you have displayed this past week through this tragedy. Your actions and leadership during this crisis have brought comfort and strength for millions of us in our Nation and throughout the world who have been affected by horrific attack.

I'm honored to have met and worked with you through USCM during my time as Mayor of Redondo Beach.



Subject: An Activist Letter on the Orlando Massacre

"Thou shalt not be a victim, thou shalt not be an oppressor. But above all, thou shalt not be a bystander." - Yehuda Bauer on the Holocaust

My name is Olivia Pierce, and I am a fourteen-year old African-American girl from Edina, Minnesota. In light of the recent horrors plaguing our nation and our American people, I would like to bring an urgent matter to your attention.

On the morning of March 7th, 1965, Martin Luther King Jr. and several other civil rights activists led more than six hundred marchers on a peaceful protest across the Edmund Pettis Bridge in Selma, Alabama. However, they were met with a barricade of policemen and state troopers. They refused to turn back. Hence, they were brutally mauled by police dogs and attacked with billy clubs and tear gas. Over fifty people were hospitalized.

On the morning of June 12th, 2016, Omar Mateen stormed the Pulse nightclub with two semi-automatic weapons and opened fire, murdering forty-nine innocent people and injuring fifty-three more. He acted viciously on what we know was an intense feeling of hatred and intolerance, just like those Alabamian policemen did almost fifty years earlier.

This attack on the LGBT community was fueled by a cultivated feeling of nefarious loathing that has existed far longer in the United States than you may suppose. The evil disdain has woven itself like a weed through our society, from the times of slavery to the cases of police brutality and now to this, the largest massacre in our country's history. *This deep-rooted parasite will not go away.* In the land of the free and the home of the brave, no one should be in danger for their lives because of who they want to love. We have to live up to our nation's promise of justice for all, not just for the straight, white, male population.

We have to save our country from the descending shadow that is hatred and intolerance. We can make our nation better, but to do that, we must act. We cannot simply shake our heads, mutter our condolences, and then turn away and carry on with our lives. As Martin Luther King Jr. said, "Our lives begin to end the day we become silent about things that matter." Don't be silent now. Expecting someone else to solve this problem won't do anything, because that's what everybody else is doing. This is an urgent issue. If we don't act now, I'm sure you are aware that these sorts of horrible monstrosities will continue to happen again and again.

We have to do something. Firstly, we need laws focused on gun control. We all have the right to bear arms, but if we were to look at the uses for a semi-automatic weapon, we would see that it is almost never used for a good reason. In the United States last year *alone*, 12, 942 people died to due gun-related homicides and suicides. Allowing your average American to buy an assault rifle after filling out a few forms is certainly not going to prevent future shootings. You could argue that you need one to protect your house and your family. Well, there's a chance that you may encounter a criminal near your home, but you don't need a semi-automatic weapon to defend yourself, especially if an enemy is at close range. In fact, keeping a semi-automatic rifle puts your family at more risk than if a criminal *did* break into your house. When a child or teen is killed by a gun, 72% of the time it is a weapon found in their own home. You might like to use your assault weapon to go hunting for sport. If you are need a 25-round magazine to successfully hit a rabbit, then you should not be hunting without proper training and practice, rather than killing solely for the purpose of exercising your superiority. We don't need semi-automatic weapons, and allowing them to be privately-owned with virtually no regulations is not the way to go if our main priority as a country is in preserving more American lives.

Secondly, we need to educate our children on ideas of equality. We need to teach them that everyone is equal and that we are all people with the same beating hearts under our different-colored skin or the different hands we wish to hold. To quote Kellin Quinn, the lead singer of a band born in Orlando, "If we hope to be free, it takes you and me, to start over here and now. 'Cause this world is the way it is. It's how we raise our kids." We have to raise our community - the children in our schools and homes - with notions of tolerance and love, so that we can strip away that feeling of hatred and ignorance.

Finally, we cannot deflect this cruelty onto another group. We can't scapegoat the Muslim community as a reason for the evil residing in the United States. The Islamic law urges Muslims to be tolerant and helpful to all people, and to be reflections of mercy, justice, and love. There is a group radical Muslims, but we cannot assume that this means all Muslims are bad. (We don't blame all Christians for the killing of a doctor who provided women the right to choose abortion by one radical Christian.) After all, Muhammad Ali was Muslim, and to assume such a thing would be to soil his memory and all that he stood for as a civil rights activist. Fighting against each other will only fuel the intolerance that has already spread its way through all of our modern society. We must turn our attention towards eliminating the evil instead of focusing so hard on destroying the evil-doer.

Those people did not deserve to die, not by any means. They were killed because of prejudice and discrimination, and as American people, we all allowed it to happen. We need to act now and prove that their deaths were not in vain. Don't just slip this horrific tragedy under the rug. Our country is falling rapidly into pandemonium, but it's not too late. We can preserve the promise inalienable rights such as life, liberty, and the pursuit of happiness. We can fight for our fundamental human rights. I have unfailing faith that justice will prevail.


